Assumption of the Risk and Waiver of Liability Relating to Coronavirus/ COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, provincial, and local governments such as the Regional Municipality of Ottawa and federal and provincial health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Lost Baggage Musical Theatre (LBMT) has put in place preventative measures to reduce the spread of COVID-19 at its rehearsals and performances however, LBMT cannot guarantee that you will not become infected with COVID-19. Further, attending rehearsals and performances could increase your risk of contracting COVID-19.

I understand that this Assumption of the Risk and Waiver of Liability agreement is in addition to, and is not a substitute for, any other documentation or registration information that I might be required to execute by the Regional Municipality of Ottawa or Lost Baggage Musical Theatre.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending the rehearsals, performances or similar activity and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at rehearsals, performances, or similar activities may result from the actions, omissions, or negligence of myself and others, including, but not limited to, LBMT, including the cast and crew of Surely, Schwartz, the LBMT Board of directors as well as potential volunteers pertaining to the show.

I acknowledge that I have received training from Lost Baggage Musical Theatre on COVID-19 prevention in regards to rehearsals and performances and understand the additional protocols and prevention procedures required of me. I agree to do my best to adhere to these protocols and prevention procedures throughout the process of Surely, Schwartz. I also understand the risk of infecting others and spreading COVID-19 outside of LBMT business and events and will do my best to comply with municipal, provincial and federal COVID-19 guidelines and protocols.

I VOLUNTARILY AGREE TO ASSUME ALL OF THE FOREGOING RISKS AND ACCEPT SOLE RESPONSIBILITY FOR ANY INJURY TO MYSELF (INCLUDING, BUT NOT LIMITED TO, PERSONAL INJURY, DISABILITY, AND DEATH), ILLNESS, DAMAGE, LOSS, CLAIM, LIABILITY, OR EXPENSE, OF ANY KIND, THAT I MAY EXPERIENCE OR INCUR IN CONNECTION WITH MY ATTENDANCE TO ANY REHEARSALS OR PERFORMANCES OR SIMILAR ACTIVITIES DURING THE PARTICIPATION IN LOST BAGGAGE MUSICAL THEATRE'S PRODUCTION OF SURELY, SCHWARTZ ("CLAIMS"). ON MY BEHALF, I HEREBY RELEASE, COVENANT NOT TO SUE, DISCHARGE, AND HOLD HARMLESS TO LOST BAGGAGE MUSICAL THEATRE OF AND FROM THE CLAIMS, INCLUDING ALL LIABILITIES, CLAIMS, ACTIONS, DAMAGES, COSTS OR EXPENSES OF ANY KIND ARISING OUT OF OR RELATING THERETO.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Lost Baggage Musical Theatre, any individuals involved in the process of Surely, Schwartz as well as the Board of Directors of LBMT whether a COVID-19 infection occurs before, during, or after participation in Surely, Schwartz.
